## **Training Update**

As you will be aware multi-agency training (face to face) has been suspended since lockdown and the decision has been made to extend this period until the end of the year 2020.

However, as a practitioner in Gloucestershire working to safeguard children and young people you will be able to stay up to date with your safeguarding training through our NEW virtual training courses which will be online.

We are in the process of re-designing our multi-agency courses to ensure they are relevant, inter-active and engaging, and ensuring that learning from Serious Case Reviews, Rapid Reviews and Child Safeguarding Practice Reviews are embedded. This we will deliver through a well-established, web-based teaching tool called the Big Blue Button.

In the following months we will begin by offering our mandatory Child Protection courses and courses linked to the priorities of the GSCE i.e. neglect, domestic abuse and child sexual exploitation, gradually bringing on board all of our other training courses in a phased plan. We will also offer a range of safeguarding e-learning programmes which form part of a blended learning approach and support internal training that practitioners receive in their own agencies or organisations.

- During this Covid-19 period, the GSCE has developed an online Learner Management and booking
  system, which will support practitioners in upskilling their knowledge by offering a range of blended
  learning opportunities in the form of a Library of virtual multi-agency training courses, recommended
  e-learning courses, complementary 40 minute to one hour themed webinars, which are either 'live'
  or pre-recorded; and links to safeguarding briefings, videos and other useful resources.
- In addition, we will offer briefings and online webinars on the findings from selected local Rapid Reviews undertaken in the county in the last six months and Local Child Safeguarding Practice Reviews.

- Going forward, we have a webinar due for delivery on October 14th around the Rapid Reviews held in the county recently. This will be delivered by the Business Manager of the Safeguarding Support Unit for the GSCE. Joining instructions will come out to you w/c 5th October.
- There also are three free webinars in the pipeline from GCC to support schools through the process of long term recovery. Once we are able to share further details of these, we will.

Something to think about:

"A client has a meeting with social workers. Her children are on the child protection register due to domestic abuse perpetrated by their father. The social worker is reviewing the list of things their mum must do under the safety plan. There are 14 things on the list. The father, the reason we are all there, isn't even required to turn up to the meeting.

I am her voice when she feels unable to speak. I am a fierce advocate, articulating the level of responsibility they are placing on the survivor of abuse – and comparing it with that given to the perpetrator."

## From Unnoticed to Invisible: The Impact of COVID-19 on Children and Young People Experiencing Domestic Violence and Abuse

## Safeguarding for administrators We've got quite a lot going on for your School Business Managers / administrators between now and when we next meet for a Hub. Today and next Weds we are running virtual course purely for administrators. This is the second time we've run this course and it's proving an eye opener for everyone! W/C 28<sup>th</sup> Sept the team are running a full week of Single Central Record check in sessions and we are 6 fully booked on each day © We plan to run SCR check in sessions monthly, as demand seems to require that, so further dates will be available soon. Do check in with your admin teams and see if they ned any support with safeguarding, or if there is anything they can do to support you with safeguarding within your settings. Neglect Last time we heard from the Community Social Work team about raising the profile of using the GSCE Neglect Toolkit. Recent Serious Case Reviews and Rapid Reviews have identified that neglect of children and young people in the county is being un-noticed and un-reported, so it is a high priority issue for the GSCE to address. The Community Social Worker, Nichola Spear advised that the toolkit should not be seen as a single agency tool and they are happy to help with talking to families and completing the toolkit. Email 7 queries and toolkits to neglecttoolkit@gloucestershire.gov.uk The University of Bristol have produced a paper, drawing on research from a Health and Care Research Wales funded study into how schools identify and respond to child neglect. It provides recommendations for best practice for school staff and social workers in child protection teams, and broader messages for inter-professional safeguarding practice. This document will be included with the notes for this meeting on the Education pages of the GSCB website. It's not an instruction manual, just a piece of reading for information! Possible Scam - advised by Police A colleague whose wife is a Headteacher in another area contacted me last week as her school had received an unsolicited DVD named 'Respecting Relationships' a few months back via post. They thought nothing of it and stored it away but have now received an invoice for £68 for said DVD, and are concerned this may be a 8 scam of sorts. It's not something we've come across before so we're unsure if it is a scam, or just unusual / questionable sales tactics. We have done some research on the company name to no avail – their website and social media accounts are dormant and there is no record of said company on Companies House, etc. The invoice didn't have any company / VAT numbers either.

## 2. Update from Education Research in MASH

Halah Shams El-Din, Senior Education Researcher, reminded everyone to ensure that their Operation Encompass alerts were being received by at least three people in school to avoid them not being picked up. She also asked schools to remind staff to not be too trusting. They have become aware that some schools are giving out information without being 100% sure who they are talking to. Most schools know Halah and her team but no-one will mind you double checking before giving out information. This is especially important for those new members of staff who don't know the team. Attached are two documents that explain Operation Encompass and the work of Halah's team.
