The merging of Education and Social Services

Gloucestershire County Council has been going through a period of change, prompted by the changes in our administration following the May 2005 council elections and by changes in legislation e.g. the 2004 Children's Act and the Green Paper *Every Child Matters*.

In September 2005, a report was taken to Cabinet setting out the change programme. These changes have been effective since 01 April 2006 and included the merging of the children's services from the Social Services and Education Directorate. The new directorate is called the: Children and Young People's Directorate.

IN DEPTH Working Together: Updated Guidance Issued by DfES

The guidance, "Working Together to Safeguard Children 2006" has now been published by the DfES.

This guidance builds upon the version that was published in 1999 and reflects developments in legislation, policy and practice, in particular the Children Act 2004 and the Every Child Matters Green Paper. It aims to provide an inter-agency framework to safeguarding and promote the welfare of children and young people. The guidance is addressed to all practitioners and front-line managers who have particular responsibilities for safeguarding and promoting the welfare of children, and to senior and operational managers in organisations that are responsible for safeguarding, commissioning or providing services to children, young people and their families.

The Gloucestershire Safeguarding Children Board (GSCB) which was established on 1st April 2006 had been awaiting this guidance and Chapter 3 details the roles and responsibilities of the Local Safeguarding Children Boards. Most measures must be introduced by October 2006.

Changes include:

- There is now no reference to a Child Protection Register and we are expected to stop using the term by April 2008. There will still be child protection conferences and we will still need to keep a record of those children that are the subject of a child protection plan and the category of concern as now. This will not affect the need to 'log a child welfare concern'.
- There is also greater prominence given to the strategy discussion, the multi-agency vehicle to start a child protection enquiry.
- Clearer advice about how to respond to the sexual activity of young people under 18, 16 and 13 years of age.
- New guidance on
 - o dealing with allegations against staff from all agencies.
 - o Individuals who pose a risk to children.
 - o Trafficked children and unaccompanied asylum seeking children.
- Guidance on responsibility to set up the new child death overview panel for all under 18s and ensuring procedures are in place to investigate child deaths which weren't expected 24 hours before they happened.
- The requirement for stronger links between Safeguarding and Domestic Abuse agencies and MAPPP.
- Definitions of responsibilities and funding for lead child protection nurses and doctors. It also outlines the safeguarding roles for paediatricians and dentists.

No doubt there are more changes and the GSCB will be looking at the Gloucestershire Child Protection Procedures (www.glosacpc.org.uk/procedures) again soon to ensure they achieve all that is expected of them. Practitioners must continue to follow Version 2 of the procedures. Child Protection Unit (CPU) becomes the Safeguarding Children Service (SCS)

Following the structure changes within the Children and Young People's Directorate and the appointment of the Safeguarding Children Manager, the administration and training services of the Safeguarding Board, together with the Child Protection Unit have now come together under one management, which will be line managed by Jo Grills, Director of Learning and Development and GSCB Chair.

Children and Young People's Plan

The Children and Young People's Plan is Gloucestershire's first single, strategic, overarching plan for all partners and agencies across the county who are jointly responsible for services to children and young people.

The plan identifies what we are collectively going to do, and how we are going to do it. The focus is on areas most in need of improvement, and where better joint working should result in better outcomes for children and young people.

The plan is being created to meet the requirements of the Children Act 2004 and the National Service Framework for Children, Young People and Maternity Services. More importantly, it has also been created to enable all organisations to address the issues which matter most to children, young people and their families.

Safe Recruitment

In January this year, the media reported that several sex offenders were working in schools throughout the country which resulted in Ruth Kelly (Secretary of State for Education and Skills) announcing a new vetting regime for people who work with children.

There are now clearer guidelines about the use of the CRB check and the use of List 99 and other similar databases.

The recommendations are outlined in the following documents:

Gloucestershire County Council Response to Ruth Kelly's statement on 19 January 2006 was as follows:

Jo Davidson, Director of Children's Services, said: "We welcome the Secretary of State's announcement today that the procedures for vetting and checking the history of all teaching staff will be much more rigorous and consistent. The safety of children is paramount. Gloucestershire County Council has always taken a robust approach to assessing the suitability of a teacher's employment in our schools and, in fact, anyone working with children. For some time now, we have regarded the enhanced CRB check as more important than List 99 but there must be no room for doubt. We do want to know whether today's announcements apply to anyone working with children, not only school teachers. We will be asking the GSCB to ensure that effective monitoring processes are in place across all services to children, including the voluntary sector, youth services, independent schools and transport providers, as well as state schools."

As a consequence the GSCB have made Safer Recruitment a business priority for its first year and will be carrying out an audit of agencies and organisations working with children and families throughout Gloucestershire. The purpose will be to raise the profile of safer recruitment, to be certain children in Gloucestershire are not at risk and to identify any areas of weakness.

<u>Safer Recruitment online training</u> has been commissioned by the DfES and developed by NCSL in response to recommendation 16 of the Bichard Inquiry report (published in June 2004).

CEOP Centre

The UK's new Child Exploitation and Online Protectection (CEOP) Centre has been launched to protect children from sexual abuse and is formally part of the Serious Organised Crime Agency.

Today's children are sophisticated users of mobile phones and the internet and protecting them in this environment needs an effective response. The Centre is a world first and will play a decisive part, with police forces, offender managers, children's services and other stakeholders, in protecting children, young people, families and society from paedophiles and sex offenders; in particular from those who use the internet and other new technologies in the sexual exploitation of children. Sharing Information about Children and Young People

The DfES has also issued guidance on:

Information sharing and the Common Assessment Framework, Multi-agency working

Communication between those working with children and young people is key to successful joined up working across services, as set out in Every Child Matters: Change for Children. Through improved information sharing and a common approach to assessing children's needs, we can help to ensure that:

- all children and young people get access to the universal education, health and other services to which they are entitled;
- children and young people with additional needs get the right services at the right time;
- there is effective safeguarding for children at risk of harm.

There are a number of things happening nationally to help practitioners and organisations to communicate and share information. This includes:

- a national information sharing index for all local areas the government aims to have an operational index in
 place by the end of 2008, containing basic information on all children, together with contact details for any services they
 are receiving. It aims to enable practitioners to identify and contact one another easily and quickly, so they can share
 relevant information about children who need services, or about whose welfare they are concerned. Local authorities will
 be responsible for maintaining the accuracy of data for children living in their area, regulating user access and training.

In January, Gloucestershire County Council signed up to an Information Sharing Principles Agreement, supported by other key agencies in Gloucestershire. The agreement covers the purposes of sharing information and principles for the lawful exchange of data within and between organisations.

An on-going training programme will be available for those working with children and young people in Gloucestershire. This will clarify the legal requirements for sharing information and aims to give practitioners confidence in making decisions. For more details click: Gloucestershire's Information Sharing Plan

KEY POINTS:

Log Child Welfare Concerns before and even if making a referral.

A Child Welfare Concern must be logged every time a professional from an agency represented on the GSCB has a child welfare concern. This must be done by ringing 01452 42 5144 (Safeguarding Children Service) during normal office hours.

Professionals must seek advice from the SCS team regarding whether a referral to the Children & Families Help Desk is necessary.

If it is then please ring 01452 42 6565 during normal office hours, to make a formal referral.

Decisions whether or not share information regarding under-age sexual activity must be properly documented.

Decisions in this area need to be made by, or with the advice of, people with suitable competence in child protection work such as named or designated professionals or senior managers. The child's best interests must be the overriding consideration in making any such decision including in the cases of underage sexual activity.
